# COVID-19 IMMUNIZATION EXEMPTION FORM

Greenhills School requires all eligible students to be fully vaccinated against COVID-19. Any families/students requesting an exemption must complete this form by August 6. There are three categories of exemption: religious, medical, or awaiting full approval from the U.S. Food and Drug Administration (an exemption based on the current Emergency Use Authorization status of the COVID-19 vaccines).

Students and families should understand that those who claim an exemption may be asked to leave campus and not participate in any school activities during a COVID-19 outbreak if it is determined that such students are at risk for contracting COVID-19 and transmitting it to other students. The length of time a student is excluded from campus and school activities will be made in consultation with public health authorities and may range from several days to several weeks. Any student with an exemption will be required to provide a negative COVID PCR test when returning to campus after school vacations. Students will be required to participate in on-campus COVID testing, they may be required to wear masks indoors or when competing in athletics, and the Health Center must approve any requests to leave campus. Finally, parents and guardians must assume responsibility for their student upon notification of a positive COVID-19 diagnosis or exposure.
